

ZOOM DEPOSITION CHECKLIST

Before

- ☐ Notice of Deposition (video, videoconference, recorded)
- ☐ Webcam / microphone check
- ☐ Decent lighting (webcam with lighting?)
- ☐ Be the Host (either schedule or scheduler makes you host)
- ☐ Meeting settings: allow join-before, allow screen sharing, disable waiting room)
- ☐ Verify witness-side equipment (facility, reporter, counsel)
- ☐ Test-run with location / facility / client / opposing counsel

During

- ☐ DON'T FORGET TO HIT 'RECORD.'
- ☐ Good witness view / framing / lighting
- ☐ Opposing counsel visible (own device)
- ☐ On-record agreement no client communication
- ☐ "Pin" the deponent's screen
- ☐ Off-Record = Pause Recording (no Stop!)
- ☐ Mark exhibits in Adobe as you go

After

- ☐ Zoom "processes" video
- ☐ Share video with opposing counsel (YouTube?)
- ☐ Print Exhibits & Reporter
- ☐ Enjoy not having to travel
